Official Rules

NO PURCHASE REQUIRED TO ENTER OR WIN

1. **ELIGIBILITY:** This Sweepstakes is open only to legal residents of the United States of America (excluding Puerto Rico) and Canada (excluding Quebec) who are 18 years of age or older as of the start of the Sweepstakes Period;
